#### Article 1

The Aim of this Cooperation Agreement (hereinafter referred to as the Agreement) entered into between "Kosovo Turism" LLC, and the Faculty of Economics of the University "Ukshin HOTI" Prizren which deals with maintaining the professional internship of students of the Faculty of Economics.

#### Article 2

The Faculty of Economics of "Ukshin HOTI" University in Prizren has the following branches, where students need to complete professional internship in your organization.

"Kosovo Turism" L.L.C is obliged to provide students of the Faculty of Economics of "Ukshin HOTI" University of Prizren with conditions for professional internship within 15 days.

#### Article 4

Students studying in the aforementioned programs, the faculty is obliged to arrange for the students who have passed the required exams and who must maintain professional internship to arrange and provide official document that they can continue the internship in the aforementioned undertaking for a fixed period of 15 working days or 60 hours.

#### Article 5

The enterprise is obliged to provide interns with working conditions and working environment so that students of the Faculty of Economics can practice their profession while they are in internship in the above mentioned enterprise.

#### Article 6

The enterprise is obliged to provide students with a written confirmation that they have completed a professional internship in their organization after completing the internship.

#### Article 7

Enterprises according to the needs and requirements may hire lecturers of the Faculty of Economics to carry out professional expertise. The terms of cooperation for expertise will be defined by contract.

### Article 8

The Agreement has a validity period of three (3) years of cooperation with the possibility of extension for other periods of time.

#### Article 9

The cooperation agreement is signed in 2 identical copies in Albanian language.

All copies have the same legal force and are valid for all signatories.

This Agreement shall enter into force on the day of signature by the signatories.
